a. Local Rules – Relief from Shells and Stones

A January 10, 2024 rules revision sheet states that relief may be taken from areas covered by crushed shells or similar material. Members expressed concern over the ambiguity of “or elsewhere” and “or similar.”

Revised Rule: Crushed Shell/Sand Mixture Areas apply only to Holes 8 and 15. Areas considered an extension of the cart path—either entering or departing—and that are 100% covered with crushed stone (no discernible soil) qualify for relief. **Relief**

Procedure: Drop at the nearest point of full relief (stance and swing), no nearer the hole.
